

## **Prize Competition Terms & Conditions**

The following terms & conditions apply for the participation in RECOM's prize competitions:

1. Prize competitions are only open to non-employees of the RECOM Group, their immediate families, persons connected with the competition/prize draw and their immediate families.
2. The participation does not require any purchase of RECOM products.
3. The participation in the prize competition is subject to the complete filing of the prize competition form prior to the lapse of the Deadline. By entering the competition, you hereby warrant that all information submitted is true, current and complete. RECOM reserves the right to verify the eligibility of all participants.
4. The participation is free of charge and reserved for participants with the age of 18 or older. RECOM reserves the right to verify the age of a participant.
5. Only those participants are considered for the prize competition, who have filled out all relevant details. The participant himself is responsible for the validity of the stated data. RECOM reserves the right to disqualify any participant if it has reasonable grounds to believe the participant has breached any of the prize competition rules.
6. Each participant may participate only once in the prize competition.
7. The Prize winner will be chosen at random from all qualifying participation entries within 30 days after the Deadline.
8. The draw is final and will be without recourse to courts or any legal actions; any rights deriving from a violation of data protection rights shall remain unaffected herefrom.
9. Any cash disbursement in exchange for the prize and/or replacement of the prize including the transfer to other third parties is excluded.
10. Prize winners will be notified by RECOM via e-mail to the address stated in the participation form. Return of any prize notification as undeliverable or failure to reply as specified in the notification (and within the time stated) may result in disqualification and selection of an alternate winner.
11. If you are chosen as a winner of the competition you will be required to reply to any email on behalf of RECOM within 14 days. Failing to do so will result in the loss of the entitlement for testing.
12. All taxes, insurances, transfers, spending money and other expenses (including meals or personal expenses upgrades etc.) as the case may be, unless specifically stated, are the sole responsibility of the prize winner.

13. RECOM reserves the right to suspend/terminate any prize draw at any time if it has reasonable ground for doing so, in particular in the event of any wilful attempt to breach these terms and conditions.
14. RECOM cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any participant entering the prize competition or as a result of accepting any prize. Nothing shall exclude RECOM's liability for death or personal injury as a result of its negligence.
15. Winners may be requested to take part in promotional activity and RECOM reserves the right to use the names and addresses of winners in any publicity both in paper and online.
16. Any personal data relating to participants will not be disclosed to a third party without the individual's consent. Please see the RECOM Data Protection Notice for further details. 17. By providing RECOM with your personal data you consent to RECOM transferring your personal data to countries or jurisdictions which do not provide the same level of data protection as in the EU.
18. This prize competition and these terms and conditions will be governed by Austrian law and any disputes will be subject to the exclusive jurisdiction of the courts of Linz, Austria.
